Directions: 586 N. Refugio Road, Santa Ynez, CA 93460 From Northbound Highway 101: Exit Buellton/Highway 246. Turn Right onto Highway 246. Proceed 5.9 miles to stoplight at Refugio Road. Turn Right on Refugio Road. Proceed 0.7 miles to A & A Equestrian/Etcetera Farm driveway on Left. Turn Left and proceed to trailer parking. From Southbound Highway 101: Exit Highway 154/San Marcos Pass. Turn left onto Highway 154. Proceed 4.9 miles to Roblar Avenue. Turn right. Almost immediately, turn left onto Refugio Road and continue 3.3 miles (straight through the stoplight at Highway 246). A & A Equestrian/Etcetera Farm will be on the left. Turn left into the driveway and proceed to trailer parking.

Return checks=\$25.00. **Refunds:** Before Close Date-Full Refund. After Close Date -Less \$50.00 non-refundable office fee. Competition cancellation- No refund, but credit toward future competition. Neg.Coggins required within 12 months for out of state horses.

Awards: Ribbons and prizes through 6th place for individual phases. Overall awards through 6th place. Cash and Prizes 1st - 3rd Place. Amounts TBA. At show III, year-end awards will also be given for the high-point competitors in each division, plus the Susan B. Davidge Memorial Sportsmanship Award will be given.
